ORDER

By the Court's March 15, 2012 Order, attorney Felicia G. Peoples (AIS No. 0212190039) was prohibited from the further practice of law in the State of Maryland for failure to comply with the obligations imposed by Rule 19-605. Attorney Peoples has now requested reinstatement pursuant to Rule 19-606(c), and the Trustees of the Client Protection Fund have confirmed attorney Peoples's compliance with Rule 19-605.

By the Court's March 21, 2013 Order, attorney Thomas F. Mapp (AIS No. 8612010334) was prohibited from the further practice of law in the State of Maryland for failure to comply with the obligations imposed by Rule 19-605. Attorney Mapp has now requested reinstatement pursuant to Rule 19-606(c), and the Trustees of the Client Protection Fund have confirmed attorney Mapp's compliance with Rule 19-605.

By the Court's March 24, 2016 Order, attorney James B. Doran (AIS No. 0006210118) was prohibited from the further practice of law in the State of Maryland for failure to comply with the obligations imposed by Rule 19-605. Attorney Doran has now requested reinstatement pursuant to Rule 19-606(c), and the Trustees of the Client Protection Fund have confirmed attorney Doran's compliance with Rule 19-605.

By the Court's March 24, 2022 Order, attorney Rhonda M. Cowie (AIS No. 0112110146) was prohibited from the further practice of law in the State of Maryland for failure to comply with the obligations imposed by Rules 19-409(c) and 19-503(c). Attorney Cowie has now requested reinstatement pursuant to those Rules, and the Administrative Office of the Courts has confirmed attorney Cowie's compliance with Rules 19-409(c) and 19-503(c).

By the Court's March 25, 2025 Order, attorney Edrei G. Swanson (AIS No. 9906240397) was prohibited from the further practice of law in the State of Maryland for failure to comply with the obligations imposed by Rule 19-605. Attorney Swanson has now requested reinstatement pursuant to Rule 19-606(c), and the Trustees of the Client Protection Fund have confirmed attorney Swanson's compliance with Rule 19-605.

Accordingly, it is this 28th day of April 2025, by the Supreme Court of Maryland,
ORDERED that attorneys

Felicia G. Peoples (AIS No. 0212190039),
Thomas F. Mapp (AIS No. 8612010334),
James B. Doran (AIS No. 0006210118),
Rhonda M. Cowie (AIS No. 0112110146), and
Edrei G. Swanson (AIS No. 9906240397)

are restored to good standing by the Court and are again permitted to practice law in the State of Maryland; and it is further

ORDERED that the Clerk of this Court shall send notice in accordance with Rule 19-761.
